The Single Family Design Board (SFDB) will hold a public hearing to give the public an opportunity to be heard and offer comments early in the review process on architectural design related issues or development plan approval findings regarding the subject property below:

Project Description: **Proposal to replace a carport with two-uncovered parking spaces, per the uncovered parking exception for properties developed with less than 80% of the required floor-to-lot area ratio (FAR). The proposal also includes the 'as-built' 396 square foot first-floor addition and alterations and reductions to an existing second-story deck. Other site alterations include 53 square feet of new permeable paving, the addition of 13 linear feet of a 5-foot tall wrought iron fence, permit an 'as-built' air-conditioning unit, and the removal of a shed and outdoor fireplace. The proposed development total of 2,321 square feet, located on a 10,299 square foot parcel, is 61% of the required floor-to-lot area ratio (FAR). The proposal will address violations identified in ZIR2012-00448 and ENF2012-00828.**

Public comments will be allowed during review of the project by the SFDB. The SFDB is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Comments on private views and privacy issues are only partially within the SFDB's authority. Due to time constraints, individual comments may be limited to two minutes. Written comments are also welcome up to the time of the hearing, and should be addressed to the City Planning Division, P.O. Box 1990, Santa Barbara, CA 93102-1990, or by e-mail to SFDBSecretary@SantaBarbaraCA.gov.

This hearing is for design review only. If the project requires approval by the Planning Commission or the Staff Hearing Officer, you will receive a notice for that public hearing. The scope of this project may be modified under further review.
