The Single Family Design Board (SFDB) will hold a public hearing to give the public an opportunity to be heard and offer comments early in the review process on architectural design related issues or development plan approval findings regarding the subject property below:

Project Description: **Proposal for a facade remodel, interior remodel and additions to an existing, 2,007 square foot, one-story, single-family residence, including a one-car garage, located on a 3-acre parcel in the non-appealable jurisdiction of the Coastal Zone. The proposal includes 730 square feet of one-story additions, and conversion of 740 square feet of existing, unfinished, basement area into new floor area. The proposal includes one, new, uncovered parking space, and a total of 440 square feet of new decks, including a new roof deck with exterior stairs. The proposed total of 3,477 square feet is 57% of the guideline floor-to-lot area ratio (FAR).**

Public comments will be allowed during review of the project by the SFDB. The SFDB is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Comments on private views and privacy issues are only partially within the SFDB's authority. Due to time constraints, individual comments may be limited to two minutes. Written comments are also welcome up to the time of the hearing, and should be addressed to the City Planning Division, P.O. This hearing is for design review only. If the project requires approval by the Planning Commission or the Staff Hearing Officer, you will receive a notice for that public hearing.
