The Single Family Design Board (SFDB) will hold a public hearing to give the public an opportunity to be heard and offer comments early in the review process on architectural design related issues regarding the subject property below:

parking exception for properties developed with less than 80% of the maximum net floor-to-lot area ratio (FAR). This application will abandon the proposal to construct a one-car carport, and requests final inspections for site work (including a driveway gate, balcony, decks, and trellis) completed under the expired building permit BLD97-02340. The existing 4,800 square foot parcel is developed with an existing 1,256 square foot, two-story, single-family residence and is 53% of the floor-to-lot area ratio (FAR). The proposal will address violations identified in ENF2013-00979.

Public comments will be allowed during review of the project by the SFDB. The SFDB is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Comments on private views and privacy issues are only partially within the SFDB's authority. Due to time constraints, individual comments may be limited to two minutes. Written comments are also welcome up to the time of the hearing, and should be addressed to the City Planning Division, P.O. Box 1990, Santa Barbara, CA 93102-1990, or by e-mail to SFDBSecretary@SantaBarbaraCA.gov.
