The Single Family Design Board (SFDB) will hold a public hearing to give the public an opportunity to be heard and offer comments early in the review process on architectural design related issues regarding the subject property below:

Project Description: **Proposal to permit "as-built" site work, to include freestanding pillars of up to 7 feet 6 inches in height, an iron pedestrian gate, an 18 inch tall garden wall, site lighting, and stone steps to an existing single family dwelling on a 22,345 square foot lot located in the Hillside Design District. This project addresses violations in enforcement case ENF2011-00950 and requires Staff Hearing Officer Review for requested zoning modifications.**

Public comments will be allowed during review of the project by the SFDB. The SFDB is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Comments on private views and privacy issues are only partially within the SFDB's authority. Due to time constraints, individual comments may be limited to two minutes. Written comments are also welcome up to the time of the hearing, and should be addressed to the City Planning Division, P.O. This hearing is for design review only. If the project requires approval by the Planning Commission or the Staff Hearing Officer, you will receive a notice for that public hearing. The scope of this project may be modified under further review.
