The Single Family Design Board (SFDB) will hold a public hearing to review architectural design-related issues regarding the subject property below:

Project Description: **Proposal to demolish 1,024 square feet of original first-floor area and a 302 square foot covered first-floor porch and construct a new 1,294 square foot first-floor addition and 94 square foot workshop with 126 square foot deck above. Also proposed is the demolition of an existing 100 square foot second-floor deck and installation of new doors, windows and landscaping. The proposed total of 2,613 square feet on a 16,207 square foot lot is 60% of the guideline maximum floor to-lot-area ratio (FAR).**

You are invited to attend the hearing and address your comments to the SFDB. The SFDB is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Private views and privacy issues are only partially within the SFDB's authority. Due to time constraints, individual comments are typically limited to two minutes. Written comments are also welcome; mail to SFDB Secretary, P.O. Box 1990, Santa Barbara, CA 93102-1990 or e-mail to SFDBSecretary@SantaBarbaraCA.gov. Please note that written comments received after 10 a.m. on the day of the meeting may not be forwarded in time for consideration by the SFDB.

ADDITIONAL INFORMATION: This hearing is for design review only. If the project requires approval by the Planning Commission or the Staff Hearing Officer, you will receive a notice for that public hearing. The scope of this project may be modified under further review. To be informed of future hearings, you may:

1. Submit a request in writing to become an "Interested Party" for notification by mail or e-mail when the project is scheduled on an agenda. Agendas are posted and mailed/e-mailed to interested parties 72 hours before the meeting.
2. Join the City's SantaBarbaraCA.gov/MySB to subscribe to e-mail notification whenever SFDB agendas posted. This is a general subscription to all SFDB agendas.

You may also contact City Planning staff at (805) 564-5578 for questions on case status or visit the Planning & Zoning counter at 630 Garden Street to review the most current plans proposed and other project documents. Office hours are 8:30 a.m. to 4:30 p.m., Monday through Thursday, and every other Friday (see SantaBarbaraCA.gov/Calendar for closure dates).

Meeting agendas, minutes, and videos are posted online at SantaBarbaraCA.gov/SFDB. This meeting will be broadcast live on City TV-Channel 18 and online at SantaBarbaraCA.gov/CityTV.

Decisions of the SFDB may be appealed to the City Council. For further information on appeals, contact Planning Division staff or the City Clerk's Office. Appeals must be in writing and must be filed with the City Clerk at City Hall within 10 calendar days of the meeting at which the Board took action or rendered its decision.
