The Single Family Design Board (SFDB) will hold a public hearing to review architectural design-related issues regarding the subject property below:

Project Description: **Proposal for additions and alterations to an existing 2,490 square foot, two-story, single-family residence with a 468 square foot attached two-car garage. The proposed project consists of 154 square feet of first-floor additions and 215 square feet of second-story additions. Other site improvements include an interior remodel of 100 square feet, a 68 square foot second-story deck addition with a new fireplace and a new 85 square foot shed at the rear of the residence. The proposed total of 3,327 square feet of development on a 13,047 square foot lot located in the Hillside Design District is 81% of the maximum allowable floor-to-lot-area ratio (FAR). The project will address violations in Zoning Information Report ZIR2013-00314. Staff Hearing Officer review is requested for a Zoning Modification request to allow additions and alterations within the required 30-foot front setback.**

You are invited to attend the hearing and address your comments to the SFDB. The SFDB is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Private views and privacy issues are only partially within the SFDB's authority. Due to time constraints, individual comments are typically limited to two minutes. Written comments are also welcome. Please note that the SFDB may not have time to consider written comments received after 10 a.m. on the day of the meeting.

If the project requires approval by the Planning Commission or the Staff Hearing Officer, you will receive a notice for that public hearing. The scope of this project may be modified under further review. To be informed of future hearings, you may:

Decisions of the SFDB may be appealed to the City Council. For further information on appeals, contact Planning Division staff or the City Clerk's Office. Appeals must be in writing and must be filed with the City Clerk at City Hall within 10 calendar days of the meeting at which the Board took action or rendered its decision.
