The Single Family Design Board (SFDB) will hold a public hearing to review architectural design-related issues regarding the subject property below:

Project Description: **Proposal to remodel 112 square feet of an existing kitchen, replace windows,**

relocate the front entry door and re-roof an existing 695 square foot, single-family residence with an attached 227 square foot one-car garage. Other site improvements include a new 112 square foot patio cover, three new skylights, removal of an existing wood deck and the installation of a new 494 square foot wrap around flagstone patio. The existing total of 922 square feet of development on a 3,953 square foot lot located in the Hillside Design District is 46% of the maximum allowable floor-to-lot-area ratio (FAR). Staff Hearing Officer Review is required for Zoning Modification requests to allow encroachments within the primary and secondary front setbacks.

You are invited to attend the hearing and address your comments to the SFDB. The SFDB is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Private views and privacy issues are only partially within the SFDB's authority. Due to time constraints, individual comments are typically limited to two minutes. Written comments are also welcome. Please note that the SFDB may not have time to consider written comments received after 10 a.m. on the day of the meeting.

ADDITIONAL INFORMATION: This hearing is for design review only. If the project requires approval by the Planning Commission or the Staff Hearing Officer, you will receive a notice for that public hearing. The scope of this project may be modified under further review. To be informed of future hearings, you may:

Office hours are 8:30 a.m. to 4:30 p.m., Monday through Thursday, and every other Friday (see SantaBarbaraCA.gov/Calendar for closure dates).

Decisions of the SFDB may be appealed to the City Council. For further information on appeals, contact Planning Division staff or the City Clerk's Office. Appeals must be in writing and must be filed with the City Clerk at City Hall within 10 calendar days of the meeting at which the Board took action or rendered its decision.
