Project Description: **Proposal to construct a 7'-high board form concrete wall and 6'-high wood IPE**

**fence in the front yard. The proposed project includes a Minor Zoning Exception request for a trash enclosure to be located within the interior setback. Other site improvements include new concrete pavers with gravel, new drainage swales, French drain, and associated landscaping including three new olive trees in the front yard. Also proposed is a new gas fire pit and water element. There are no proposed alterations to the existing single residential unit.**

You are invited to attend the hearing and address your comments to the SFDB. The SFDB is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Private views and privacy issues are only partially within the SFDB's authority. Due to time constraints, individual comments are typically limited to two minutes. Written comments are also welcome. Please note that the SFDB may not have time to consider written comments received after 10 a.m. on the day of the meeting.

If the project requires approval by the Planning Commission or the Staff Hearing Officer, you will receive a notice for that public hearing. The scope of this project may be modified under further review. Office hours are 8:30 a.m. to 4:30 p.m., Monday through Thursday, and every other Friday (see [SantaBarbaraCA.gov/Calendar](http://SantaBarbaraCA.gov/Calendar) for closure dates).
