The Single Family Design Board (SFDB) will hold a public hearing to review architectural design-related issues regarding the subject property below:

Project Description: **Proposal to construct 597 square feet of lower level additions to an existing 3,612 square foot two-level single-family dwelling with a detached 529 square foot two-car garage. The proposed project includes 597 square feet of expanded roof decks above the additions as well as minor door and window alterations. Staff Hearing Officer Review is requested to allow the unpermitted pergolas to encroach within the required front setback. The proposed total of 4,738 square feet of development on a 24,817 square foot lot located in the Hillside Design District is 100% of the guideline maximum floor-to-lot area ratio (FAR).**

You are invited to attend the hearing and address your comments to the SFDB. The SFDB is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Private views and privacy issues are only partially within the SFDB's authority. Due to time constraints, individual comments are typically limited to two minutes. Written comments are also welcome. Please note that the SFDB may not have time to consider written comments received after 10 a.m. on the day of the meeting.

If the project requires approval by the Planning Commission or the Staff Hearing Officer, you will receive a notice for that public hearing. The scope of this project may be modified under further review.
