The Single Family Design Board (SFDB) will hold a public hearing to review architectural design-related issues regarding the subject property below:

Address: **1708 LA VISTA DEL OCEANO DR (PREVIOUSLY 1704)**

Project Description: **Proposal to permit unpermitted alterations to an existing 4,763 square foot two-story single residential unit with an attached 697 square foot three-car garage. Unpermitted alterations include the conversion of 276 square feet of crawl space to storage area, an outdoor shower, a balcony removal and a balcony addition, exterior finish alterations and window and door changes. Staff Hearing Officer Review is required for the front setback modification requests to allow the conversion of non-habitable to habitable floor area within the required front setbacks from La Vista Del Oceano and the private road. The proposed total of 5,735 square feet of development on a 46,409 square foot lot located in the Hillside Design District is 114% of the guideline maximum floor-to-lot area ratio (FAR).**

You are invited to attend the hearing and address your comments to the SFDB. The SFDB is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Private views and privacy issues are only partially within the SFDB's authority. Due to time constraints, individual comments are typically limited to two minutes. Written comments are also welcome. Please note that the SFDB may not have time to consider written comments received after 10 a.m. on the day of the meeting.

If the project requires approval by the Planning Commission or the Staff Hearing Officer, you will receive a notice for that public hearing. The scope of this project may be modified under further review.
