The Single Family Design Board (SFDB) will hold a public hearing to review architectural design-related issues regarding the subject property below:

Project Description: Proposal for additions and alterations to an existing three-story single residential unit. The proposed project consists of redesigning to Spanish Colonial Revival style consisting of a new roof, new plaster exterior, new windows and doors, larger patio, new garage door, new elevator, and landscaping. The existing house is nonconforming to the maximum floor to lot area ratio (FAR), and is allowed a one-time addition of no more than 100 square feet of floor area. Additions of 20 square feet at the garage level, 38 square feet at the second floor, and 30 square feet at the third floor are proposed. The new elevator results in a 60 square foot reduction of floor area, and the resulting net increase is 73 square feet. Staff Hearing Officer review is requested for Zoning Modifications to allow front stair and porch alterations in the required front setback and minor additions in the required interior setback.

You are invited to attend the hearing and address your comments to the SFDB. The SFDB is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Private views and privacy issues are only partially within the SFDB's authority. Due to time constraints, individual comments are typically limited to two minutes. Written comments are also welcome. Please note that the SFDB may not have time to consider written comments received after 10 a.m. on the day of the meeting.

ADDITIONAL INFORMATION: This hearing is for design review only. If the project requires approval by the Planning Commission or the Staff Hearing Officer, you will receive a notice for that public hearing. The scope of this project may be modified under further review. To be informed of future hearings, you may:

Appeals must be in writing and must be filed with the City Clerk at City Hall within 10 calendar days of the meeting at which the Board took action or rendered its decision.
