The Single Family Design Board (SFDB) will hold a public hearing to review architectural design-related issues regarding the subject property below:

Project Description: **Proposal for additions and alterations to an existing 2,100 square foot two-story single residential unit with a detached 346 square foot two-car garage. The proposal includes a second-story addition of 541 square feet and a new 96 square foot second story deck. The proposed total of 2,641 square feet of development on a 6,200 square foot lot is 97% of the maximum allowable floor-to-lot area ratio (FAR).**

You are invited to attend the hearing and address your comments to the SFDB. The SFDB is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, and design issues. Private views and privacy issues are only partially within the SFDB's authority. Due to time constraints, individual comments are typically limited to two minutes. Written comments are also welcome. Please note that the SFDB may not have time to consider written comments received after 10 a.m. on the day of the meeting.

If the project requires approval by the Planning Commission or the Staff Hearing Officer, you will receive a notice for that public hearing. The scope of this project may be modified under further review. Office hours are 8:30 a.m. to 4:30 p.m., Monday through Thursday, and every other Friday (see [SantaBarbaraCA.gov/Calendar](http://SantaBarbaraCA.gov/Calendar) for closure dates).
