**PROJECT DESCRIPTION:** The approved project is a proposal for a 4,576 square foot single-family residence at 1701 La Vista Del Oceano (Lot 1) with a 596 square foot attached three-car garage on 22,500 square foot lot in the Hillside Design District. Review After Final is requested to permit an unpermitted trash enclosure, and for new wood doors and stucco walls to match the entry gate and walls on the property. Staff Hearing Officer review of a Zoning Modification is also requested to allow the unpermitted trash enclosure to encroach into the required 30-foot front yard setback.
