PROJECT DESCRIPTION: Proposal to construct a 767 square foot detached accessory dwelling unit (ADU) with a 446 square foot attached two-car garage. The existing 746 square foot residence is detached from the proposed ADU. Project includes new landscape and driveway improvements.
