PROJECT DESCRIPTION: Proposal to construct a new CMU wall around the perimeter of a 5,541 square foot lot with an existing 518 square foot single-unit residence and a detached 547 square foot two-car garage. The wall is proposed to range in height from 3'-6" to 8'-0" for a total of 305 linear feet. The project requires a Minor Zoning Exception to allow the wall to exceed the maximum allowed height of 3'-6" within 10 feet of the front lot line. **FOR MORE INFORMATION**
