**PROJECT DESCRIPTION:** Proposal for a 23 square foot second floor bay window addition and 324 square foot covered patio addition at the first floor of an existing 2,482 square foot existing single-unit residence with an attached 382 square foot two-car garage. Project also includes an outdoor fireplace. The project is requesting Minor Zoning Exception to allow the hedge to exceed the maximum allowed height of 8'-0". The proposed total of 2,887 square feet on a 12,905 square foot lot in the Hillside Design District is 71% of the maximum required floor-to-lot area ratio (FAR).
