PROJECT DESCRIPTION: Proposal for a new 2,756 square foot two-story residence with an attached 424 square foot two-car garage. Project also includes a 408 square foot shell above garage for a future accessory dwelling unit under a separate permit. The project includes an 11'x25' swimming pool, 1,658 square feet of uncovered and covered decks, landscaping and other associated site improvements. A total of 470 cubic yards of cut, 990 cubic yards of fill, with a net import of 520 cubic yards.
