PROJECT DESCRIPTION: Proposal for a 98 square foot addition to the first floor and a new 664 square foot second floor to an existing 856 square foot single-unit residence with a detached 162 square foot one-car garage. Project includes a new deck, new balcony, interior remodel, and relocation of the main entry.
