PROJECT DESCRIPTION: Proposal to demolish and rebuild 1,324 square feet of an existing, one-story, single-unit residence with 499 square feet of additions on the first floor, and a new 610 square foot second floor. The attached 499 square foot two-car garage is to remain. The project also includes a new 280 square foot deck.
