PROJECT DESCRIPTION: Proposal to remodel the existing covered front entry of an existing 2,530 square foot single-unit residence with a detached 460 square foot two-car garage. Project also includes cantilevered trellises, and associated landscape and hardscape improvements. Staff Hearing Officer review is requested for a Zoning Modification to allow encroachments into the required front yard setback.
