**PROJECT DESCRIPTION:** Proposal to demolish an existing 1,794 square foot, one-story, single-unit residence and construct a new 3,323 square foot, two-story, single-unit residence with a 750 square foot detached four-car garage. Project includes a new motor court, two new balconies, and 49 cubic yards of grading. The proposed total of 4,073 square feet of development on a 50,595 square foot lot is 81% of the guideline maximum floor-to-lot area ratio (FAR).
