PROJECT DESCRIPTION: Proposal for 141 square feet of additions on the first floor and a new 497 square foot second floor on an existing 1,041 square foot one-story single-unit residence with a 280 square foot detached Accessory Dwelling Unit, and 82 square feet of storage space, and two uncovered parking spaces. Project includes an interior remodel and new 115 square foot deck on the second story.
