NOTICE OF A PUBLIC HEARING: SINGLE FAMILY DESIGN BOARD (SFDB)

PROJECT DESCRIPTION: Proposal to construct a new approximately 2,755 square foot, two-story residence with an attached approximately 584 square foot three-car garage with a 33 square foot attached storage area. The project also includes a new patio, pool, and spa on a 23,333 square foot vacant lot on the coastal bluff. Grading for the project would involve approximately 340 cubic yards of cut and 35 cubic yards of fill. The proposed total of 3,339 square feet of development on a 23,333 square foot lot is 71% of the guideline maximum floor-to-lot area ratio (FAR).
