PROJECT LOCATION: 365 EL CIELITO, **ZONE:** RS-1A, **APN**021-082-005, **PLN**2018-00432 **OWNER:** WAILEA INN EL CIELITO, LLC **PROJECT DESCRIPTION:** Proposal for revisions to previously approved project. Proposal includes permitting an as-built metal fence with a stucco wall base ranging in height from 6'-0" to 7'-6", and new metal pool fence enclosures ranging from 5'-0" to 6'-0" in height. Project is requesting a Minor Zoning Exception to allow the fence height to exceed the maximum allowed height of 3'-6" within 10'-0" of the front setback and a Minor Zoning Exception to allow a trash enclosure to be located in the secondary front yard. Project requires review from the Staff Hearing Officer for a Front Yard Modification to allow accessory structures (gazebo, pool equipment shed, and a chicken coop) located within the front yard and a Front Setback Modification to allow a second driveway and parking located within the front (secondary) setback off of El Cielito Lane. **FOR MORE INFORMATION CONTACT:** ERICA MONSON, SFDB PLANNING TECHNICIAN, AT (805) 564-5541
