PROJECT DESCRIPTION: Proposal for 1,441 square feet of additions to an existing, one-story, 2,339 square foot residence with an attached two-car garage. Project includes an interior remodel, new doors and windows, revisions to the existing patio, and demolition of the existing patio cover.
