PROJECT DESCRIPTION: Proposal for a new six-lot subdivision for a future single-family residential development on a two-acre lot in the County of Santa Barbara. Project includes demolition of one existing single-unit residence, construction of a new public road, utility and infrastructure improvements, and 1,641 cubic yards of cut and 2,299 cubic yards of fill. No new residential structures are currently proposed. Project requires approval by the Planning Commission of the Street Frontage Modification and Tentative Subdivision Map, and approval by the City Council for Annexation of the two-acre lot from the County of Santa Barbara to the City of Santa Barbara, a General Plan Amendment, and a Zoning Map Amendment. **FOR MORE INFORMATION CONTACT:** ERICA MONSON, SFDB PLANNING TECHNICIAN, AT (805) 564-5541
