**PROJECT DESCRIPTION:** Proposal for 344 square feet of additions to the first floor and a new 785 square foot second story on an existing 1,415 square foot single-unit residence with an attached two-car garage. The project includes remodeling the existing 419 square foot two-car garage and including a 204 square foot addition, and a new 154 square foot second story deck.
