PROJECT DESCRIPTION: Proposal for a 233 square foot addition to the second story of an existing 2,299 square foot two-story single-unit residence. Proposal also includes a 25 square foot addition to the existing two-car garage, and improvements to the first floor covered terrace and second floor deck. Project also includes a 458 square foot Accessory Dwelling Unit (ADU) on the second story to be reviewed under a separate permit.
