**PROJECT DESCRIPTION:** Proposal for additions and alterations to an existing one-story 807 square foot single residential unit. An existing one-car garage is provided off-site (APN027-252-018). Project includes an interior remodel, converting the existing enclosed front porch into 90 square feet of habitable space, relocating the water heater, a 4 square foot bathroom addition, and replacement and alteration of existing windows. Minor Zoning Exceptions are requested for window alterations located within the required interior setbacks. Review from the Staff Hearing Officer is requested to allow the addition to encroach into the required interior setback. The proposed total of 901 square feet of development on a 2,310 square foot lot is 41% of guideline maximum floor-to-lot area ratio (FAR).
