PROJECT DESCRIPTION: Proposal for a remodel and additions to an existing 2,196 square foot single-unit residence in the Hillside Design District. Project includes a new detached 563 square foot two-car garage, 57 square feet of additions to the main residence, 209 square feet of storage space, and a 110 square foot sauna. Site improvements include landscaping, hardscaping, and new pool and spa.
