PROJECT DESCRIPTION: Proposal for a remodel and additions to an existing 4,509 square foot single-unit residence located in the Non-Appealable Jurisdiction of the Coastal Zone. Project includes demolition of existing 1,153 square foot garage to construct a new 878 square foot detached two-car garage, pool equipment, and storage area. Proposal also includes 293 square feet of additions, a new outdoor pool, raised wood decks, relocation of the existing driveways, and landscape improvements.
