PROJECT DESCRIPTION: Proposal for 396 square feet of additions to an existing 1,977 square foot, three-level, single-unit residence with an attached 441 square foot two-car garage. The project includes a new outdoor gas fireplace and barbeque counter, and permitting as-built interior alterations. The project is requesting a Minor Zoning Exception to allow the trash enclosure to encroach into the required interior setback.
