PROJECT DESCRIPTION: The proposed project is for interior and exterior improvement to an existing single unit residence. Interior improvements will include creating a new bedroom on the second floor along with electrical and plumbing repairs on both floors. On the ground floor an infill door and wall separating a family room and dining room will be removed. Exterior improvements will include two new windows on the second floor and two new windows on the ground floor. Along Island View a six foot tall fence and six foot tall double gate is proposed along the front lot line, which requires consideration of Minor Zoning Exception (MZE) by the design review board. Finally, an approximate 100 square foot storage shed adjacent to the garage would be removed. The project would abate violations identified under enforcement case number ENF2019-00745.
