PROJECT DESCRIPTION: Proposal to remove the interior garage wall of a legal nonconforming garage, expand the eastern portion of the garage to increase maneuverability, and raise the garage roof. Project also includes installing new garage doors, a new stairway and entry door to the rear of the garage. A Minor Zoning Exception is requested to allow a 6-inch increase in height to a portion of the garage roof located in the interior setback. Project requires Staff Hearing Officer review of Front and Interior Setback Modifications for additions and alterations to a nonconforming garage. The project site is located on a 6,900 square foot (approx.) lot in the Mission Area Special Design District.
