PROJECT DESCRIPTION: Proposal for a 463 square foot addition to the rear of an existing one-story single unit residence including window alterations and an interior remodel. SFDB review of a Minor Zoning Exception is requested to allow a 1-foot increase in height to a portion of the house located in the front setback. The project site is located on an 8,026 square foot lot. The proposed 2,211 square feet of development is 68% of the maximum floor to lot area ratio (FAR).
