**PROJECT DESCRIPTION:** Proposal to demolish existing single unit residence and construct a new 4000 square foot (approx.) single unit residence with a new detached garage, new pool cabana, hardscape and landscape improvements, and a new 6-foot tall site wall with remotely actuated vehicular gates and 2 pedestrian gates. An Accessory Dwelling Unit is proposed under a separate permit. The project site is located on a 102,357 square foot lot with a slope of 27% in the Hillside Design District and the Non-Appealable Jurisdiction of the Coastal Zone. The proposed 5,153 square feet of development is 90% of the maximum guideline floor-to-lot area ratio (FAR).
