PROJECT DESCRIPTION: Proposal for an 80 square foot addition to the second floor of an existing 2,019 square foot single-unit residence. Project includes removal of a window at the north elevation of the residence to be replaced with a door, improvements to the back yard patio, and installation of washer and dryer units in the existing garage. The proposed total of 2,099 square feet is 52% of the maximum required floor-to-lot area ratio.
