PROJECT DESCRIPTION: Proposal for a 255 square foot addition to the second floor of an existing 1,693 square foot single-unit residence with an existing detached 263 square foot garage. Project includes removal of a window at the north elevation of the residence to be replaced with a door, and improvements to the back yard patio. The proposed total of 2,211 square feet is 54% of the maximum required floor-to-lot area ratio.
