PROJECT DESCRIPTION: Proposal to construct a new 7890 S.F. single family residence with a 787 S.F. attached garage on a vacant lot. New landscaping, new driveway and motor court, and new retaining walls. New pool and spa under separate permit. Project site is located on a 3.25 acre lot in the Hillside Design District with an average slope of 54%. The proposed total of 7,190 square feet of development is 115% of the maximum guideline floor-to-lot area ratio (FAR).
