**PROJECT DESCRIPTION:** Proposal to convert an existing covered front porch to habitable space and to construct a new covered front porch. An interior remodel is also proposed. Staff Hearing Officer review of a modification is required to allow the enclosure of the existing covered porch to be located in the required front setback. The proposed total of 1,430 square feet of development on a 5,026 square foot parcel is 59% of the maximum guideline floor to lot area ratio (FAR).
