PROJECT DESCRIPTION: Proposal for approximately 594 square feet of additions to the main residence and a 221 square foot addition to the existing garage. Project includes a covered pool deck. The existing pool will be expanded under a separate permit. An Accessory Dwelling Unit above the existing garage is proposed under a separate permit. The proposed total of 3,354 square feet of development on a 15,246 square foot lot is 77% of the maximum guideline floor to lot area ratio (FAR).
