**PROJECT DESCRIPTION:** Proposal for six new single-family residences on a two-acre lot in the process of being subdivided and annexed into the City. Project includes demolition of one existing single-unit residence, construction of six new single-family residences, construction of a new public road, and 1,641 cubic yards of cut and 2,299 cubic yards of fill. Project received Planning Commission approval of a Street Frontage Modification and a Tentative Subdivision Map, and City Council approval of the Annexation of the two-acre lot from the County of Santa Barbara to the City of Santa Barbara, a General Plan Amendment, and a Zoning Map Amendment.
