RESOLUTION NO. 052-07 1133 ALAMEDA PADRE SERRA MODIFICATION JULY 18, 2007

APPLICATION OF ERIC SWENUMSON FOR ALPHONSO SANCHEZ, 1133 ALAMEDA PADRE SERRA, APN 029-282-006, E-1 ONE-FAMILY RESIDENCE ZONE, GENERAL PLAN DESIGNATION: 3 UNITS PER ACRE (MST2007-00060)

The 12,710 square foot project site is currently developed with a single-family residence and attached garage. The proposed project involves legalization of the "as-built" conversion of the under-story to habitable space, 333 square feet of "as-built" additions, and alterations to the front entry and rear deck. The discretionary application required for this project is a <u>Modification</u> to permit alterations and additions within the required front and interior yard setbacks (SBMC §28.15.060).

The Environmental Analyst has determined that the project is exempt from further environmental review pursuant to the California Environmental Quality Guidelines Section 15303.

WHEREAS, the Staff Hearing Officer has held the required public hearing on the above application, and the Applicant was present.

WHEREAS, no one appeared to speak in favor of or in opposition thereto, and the following exhibits were presented for the record:

NOW, THEREFORE BE IT RESOLVED that the City Staff Hearing Officer:

Approved the project, making the findings that the Modification is necessary to secure an appropriate improvement by expanding the existing residence's floor area in the existing under story which is not visible from the street due to the slope of the site and is consistent with the purpose and intent of the Zoning Ordinance. Said approval is subject to the removal of an "asbuilt" barbeque and trellis, and the recordation of a Zoning Compliance Declaration.

This motion was passed and adopted on the 18th day of July, 2007 by the Staff Hearing Officer of the City of Santa Barbara.

PLEASE BE ADVISED:

- 1. This action of the Staff Hearing Officer can be appealed to the Planning Commission or the City Council within ten (10) days after the date the action was taken by the Staff Hearing Officer.
- 2. If you have any existing zoning violations on the property, other than those included in the conditions above, they must be corrected within thirty (30) days of this action.
- 3. Subsequent to the outcome of any appeal action your next administrative step should be to apply for Architectural Board of Review (ABR) approval and then a building permit.
- 4. PLEASE NOTE: A copy of this resolution shall be reproduced on the first sheet of the drawings submitted with the application for a building permit. The location, size and design of the construction proposed in the application for the building permit shall not deviate from the location, size and design of construction approved in this modification.
- 5. <u>NOTICE OF APPROVAL TIME LIMITS</u>: The Staff Hearing Officer's action approving the Performance Standard Permit or Modifications shall expire two (2) years from the date of the approval, per SBMC §28.87.360, unless:
 - a. A building permit for the construction authorized by the approval is issued within twenty four months of the approval. (An extension may be granted by the Staff Hearing Officer if the construction authorized by the permit is being diligently pursued to completion.) or;
 - b. The approved use has not been discontinued, abandoned or unused for a period of six months following the earlier of:
 - i. an Issuance of a Certificate of Occupancy for the use, or;
 - ii. one (1) year from granting the approval.
