T. PROJECT DESCRIPTION

The current proposal is a request to extend the expiration date of the Tentative Map approved by the Staff Hearing Officer on July 19, 2006 in Resolution 043-06. The Map approval is set to expire on July 19, 2008. A three-year extension is requested pursuant to SBMC, §27.07.110.D. The applicant submitted the extension request on June 2, 2008, thereby satisfying the City's requirements for an extension request.

The project approved by the Staff Hearing Officer involves the subdivision of the Granada Tower into two two-bedroom residential condominiums units and 34,875 square feet of commercial space. The discretionary applications approved for the project by the Staff Hearing Officer were:

- Modification of the residential parking requirement for each of the two residential units 1. (SBMC§28.90) to provide no parking:
- 2. A Modification to allow a change of use (commercial to residential) in a building that is nonconforming to height (SBMC §28.87.030 D);
- A Modification to allow the private outdoor living space for Residential Unit 1 (7th 3. floor) to be provided within the existing building (SBMC §28.21.081.A); and
- 4. A Tentative Subdivision Map for a one-lot subdivision to create two residential condominium units and 34,875 square feet of commercial condominium space that may be divided into as many as 82 commercial condominium units (SBMC 27.07 and 27.13).

III. DISCUSSION

According to SBMC 27.07.110.A, B and D, Expiration and Extension of Tentative Maps, the approval or conditional approval of a tentative map shall expire twenty-four (24) months from the date the map was approved or conditionally approved. The subdivider may request an extension of the tentative map approval or condition of approval by written application to the Staff Hearing Officer filed with the Community Development Department before the expiration of the tentative map. The applicant has complied with this requirement.

The Staff Hearing Officer may impose new conditions or revise existing conditions. Staff has no recommended changes to the conditions of approval. An extension or extensions of tentative map approval or conditional approval shall not exceed in aggregate three (3) years beyond the expiration of the original twenty-four (24) month period.

The project received final design approval on August 23, 2006, and building permits to complete the remodel and renovation work included as part of the project have been issued. Existing easements on the site are very complicated, and require revisions to address final utility locations and emergency egress. These revisions have delayed recordation of the Final Map.

Staff has determined that the project is exempt from further environmental review pursuant to California Environmental Quality Act Guidelines Section 15305, Minor Alterations in Land Use Limitation, for the extension of time limits on an approved project where circumstances have not changed.

IV. RECOMMENDATION/FINDINGS

The applicant has worked diligently toward recordation of the Map. The project continues to conform to the City's Zoning and Building Ordinances and policies of the General Plan. Therefore, Staff recommends that the Staff Hearing Officer approve the three-year time extension, to July 19, 2011, for the Tentative Map, subject to the original conditions of approval in Exhibit A.

The proposed project consists of the subdivision of the Granada Tower into two (2) two-bedroom residential condominium units and 34,875 square feet of commercial condominium space. The project also includes a structural retrofit of the building, replacing the existing exterior fire escape with an enclosed staircase, a new roof and roof structure, new window dormers in the roof, creating an outdoor living area on the roof, uncovering original windows on the south elevation of the building and infilling existing windows on north elevation. This building is on the City's Potential Historic Resources list.

The discretionary applications required for this project are:

- 1. <u>Modification</u> of the residential parking requirement for each of the two residential units (SBMC§28.90);
- 2. A <u>Modification</u> to allow a change of use (commercial to residential) in a building that is nonconforming to height (SBMC §28.87.030 D);
- 3. A <u>Modification</u> to allow the private outdoor living space for Residential Unit 1 (7th floor) to be provided within the existing building (SBMC §28.21.081.A); and
- 4. A <u>Tentative Subdivision Map</u> for a one-lot subdivision to create two (2) residential condominium units and 34,875 square feet of commercial condominium space (SBMC 27.07 and 27.13).

The Environmental Analyst has determined that the project is exempt from further environmental review pursuant to the California Environmental Quality Guidelines Sections 15301, 15303 and 15315.

WHEREAS, the Staff Hearing Officer has held the required public hearing on the above application, and the Applicant was present.

WHEREAS, no one appeared to speak in favor of or in opposition thereto, and the following exhibits were presented for the record:

- 1. Staff Report with Attachments, July 19, 2006.
- 2. Site Plans

NOW, THEREFORE BE IT RESOLVED that the City Staff Hearing Officer:

I. Approved the subject application making the following findings and determinations:

A. The Parking Modification (SBMC §28.90)

A modification of the parking requirements, where the modification will not be inconsistent with the purposes and intent of the Zoning Ordinance and will not cause an increase in the demand for parking space in the immediate area.

Modification of the required parking for the two residential units associated with this project will not cause an increase in the demand for parking compared to the existing use; the site is located in the urban core in close proximity to services and shopping; and there are opportunities for privately leased parking spaces if so desired by the residential occupants of the building.

B. Building Height Modification (SBMC §28.92.110, A, 4)

A modification of building height limitations for existing buildings or structures that exceed the current building height limit, to allow the exterior of the portion of the building or structure that exceeds the building height limit to be improved or upgraded, provided that the improvements increase neither the height nor the floor area of any portion of the building or structure that exceeds the building height limit, except as otherwise allowed in the Code.

The proposed improvements will not increase the height of the building or the total floor area of the building and the change in use is necessary to finance the required seismic upgrade of the structure. Preserving this structure is important to the City as the structure is on the City's Potential historic Structure list and is eligible for the California Register of Historic Places.

C. The Private Outdoor Living Space Modification (SBMC §28.21.081, A)

The modification is consistent with the purposes and intent of the Zoning Ordinance and is necessary to secure an appropriate improvement on a lot.

The requested modification is consistent with the purposes and intent of the Zoning Ordinance in that the residential units are located in close proximity to several, public open space areas that can serve as the requisite outdoor living space, and an alternative area is provided within the unit through modified window design. These residential units are located within an existing historic structure, and private outdoor space cannot be provided without altering the exterior appearance of the building. This is a constrained site that will benefit from providing residential units in this historic building, and the alternative private space provided is consistent with the Zoning Ordinance.

D. The Tentative Map (SBMC §27.07.100)

The Tentative Subdivision Map is consistent with the General Plan and the Zoning Ordinance of the City of Santa Barbara. The site is physically suitable for the proposed development, the project is consistent with the variable density provisions of the Municipal Code and the General Plan, and the proposed use is consistent with the vision for this neighborhood of the General Plan. The design of the project will not cause substantial environmental damage, and associated improvements will not cause serious public health problems.

E. The New Condominium Development (SBMC §27.13.080)

- 1. There is compliance with all provisions of the City's Condominium Ordinance.

 The project complies with density requirements. Each unit includes laundry facilities, separate utility metering, adequate unit size and storage space, and private outdoor living space.
- 2. The proposed development is consistent with the General Plan of the City of Santa Barbara.
 - The project can be found consistent with policies of the City's General Plan including the Housing Element, Conservation Element, and Land Use Element. The project will provide infill residential development that is compatible with the surrounding neighborhood. Residential development within the existing structure makes the building's seismic upgrade financially feasible, thus improving safety for all occupants of the building as well as the general public, as well as preserving a historic resource.
- 3. The proposed development is consistent with the principles of sound community planning and will not have an adverse impact upon the neighborhood's aesthetics, parks, streets, traffic, parking and other community facilities and resources.

The project is an infill residential project proposed in an area where residential development is a permitted use. The project is adequately served by public streets and will not result in traffic impacts. The design has been reviewed by the City's design review board, which found the architecture and site design appropriate.

II. Said approval is subject to the following conditions:

In consideration of the project approval granted by the Staff Hearing Officer and for the benefit of the owner(s) and occupant(s) of the Real Property, the owners and occupants of adjacent real property and the public generally, the following terms and conditions are imposed on the use, possession and enjoyment of the Real Property:

- A. Recorded Agreement. Concurrent with recordation of the Final Map, the Owner shall execute an "Agreement Relating to Subdivision Map Conditions Imposed on Real Property", which shall be reviewed as to form and content by the City Attorney, Community Development Director and Public Works Director, recorded in the Office of the County Recorder, and shall include the following:
 - 1. Uninterrupted Water Flow. The Owner shall provide for the uninterrupted flow of water through the Real Property including, but not limited to, swales, natural water courses, conduits and any access road, as appropriate. The Owner is responsible for the adequacy of any project-related drainage facilities and for the continued maintenance thereof in a manner that will preclude any hazard to life, health or damage to the Real Property or any adjoining property.
 - 2. Recreational Vehicle Storage Prohibition. No recreational vehicles, boats or trailers shall be stored on the Real Property.
 - 3. **Approved Development.** The development of the Real Property approved by the Staff Hearing Officer on <u>July 19, 2006</u> is limited to two dwelling units, 34,875 square feet of commercial condominium space that may be divided into as many as 82 commercial condominium units, and the improvements shown on the Tentative Subdivision Map signed by the chairman of the Staff Hearing Officer on said date and on file at the City of Santa Barbara.
 - 4. **Building Height Restriction.** The height of the building shall not be increased above the existing height as verified by survey. No mechanical equipment, parapets or other features shall extend above the existing building.
 - 5. Rooftop Deck Restriction. The rooftop deck provided as private outdoor living space shall not contain any furniture or objects that exceed the height of the surrounding parapet. Any objects that have the potential to be lifted by normal wind gusts shall be fastened/tied down to avoid injury.
 - 6. **Required Private Covenants.** The Owners shall record in the official records of Santa Barbara County either private covenants, a reciprocal easement agreement, or a similar agreement which, among other things, shall provide for all of the following:
 - a. Common Area Maintenance. An express method for the appropriate and regular maintenance of the common areas, common access ways, common utilities and other similar shared or common facilities or improvements of the development, which methodology shall also

- provide for an appropriate cost-sharing of such regular maintenance among the various owners of the condominium parcels.
- b. **Trash and Recycling.** Adequate and equal space shall be provided and maintained for trash and recycling purposes, and a minimum of 50% of the waste generated by the new residential units shall be recycled.
- c. Covenant Enforcement. A covenant that permits each owner to contractually enforce the terms of the private covenants, reciprocal easement agreement, or similar agreement required by this condition.
- 7. **Lighting.** Exterior lighting, where provided, shall be consistent with the City's Lighting Ordinance and most currently adopted Energy Code. No floodlights shall be allowed. Exterior lighting shall be shielded and directed toward the ground.
- 8. **Street Tree Protection.** The street trees within the City's right-of-way shall be preserved and protected.
- 9. **Off-Site Parking.** Off-site parking, leased or purchased, shall not be required parking for another land use or building.
- B. **Public Works Submittal Prior to Final Map Approval.** The Owner shall submit the following, or evidence of completion of the following, to the Public Works Department for review and approval, prior to processing the approval of the Final Map for the project:
 - 1. **Final Map.** The Owner shall submit to the Public Works Department for approval, a Final Map prepared by a licensed land surveyor or registered Civil Engineer. The Final Map shall conform to the requirements of the City Survey Control Ordinance.
 - 2. Water Rights Assignment Agreement. The Owner shall assign to the City of Santa Barbara the exclusive right to extract ground water from under the Real Property. Said agreement will be prepared by Engineering Division Staff for the Owner's signature.
 - 3. **Required Private Covenants.** The Owner shall submit a copy of the recorded private covenants, reciprocal easement agreement, or similar private agreements required for the project.
 - 4. Off-Site Public Street Improvement Plans. The Owner shall submit building plans for construction of improvements along <u>Anapamu Street</u>. As determined by the Public Works Department, the improvements shall include new and/or remove and replace to City standards, the following: re-pave alley with asphalt concrete following construction, connection to City water and sewer mains, public drainage improvements with supporting drainage calculations and/or hydrology report for connection to existing drainage pipe and curb drain outlets, (provide off-site storm water BMP plan, etc. to Building and Safety Division),

and provide adequate positive drainage from site. Existing private sewer laterals serving the property shall be inspected by a licensed plumber and repaired if deemed necessary by the plumber before new dwellings are occupied. Any existing sewer lateral(s) identified to be abandoned, shall be disconnected at the sewer mainline connection. A licensed plumber shall verify if the property requires a backwater valve. If existing lateral already has a backwater valve, then it shall be inspected. The building plans, drainage calculations and hydrology report shall be prepared by a registered civil engineer or licensed architect. Any work in the public right of way requires a public works permit.

- 5. **Removal or Relocation of Public Facilities.** Removal or relocation of any public utilities or structures must be performed by the Owner or by the person or persons having ownership or control thereof.
- C. Public Works Requirements Prior to Issuance of Residential Certificate of Occupancy. The Owner shall submit the following, or evidence of completion of the following to the Public Works Department for review and approval, prior to the issuance of residential occupancy for the project.
 - 1. **Recordation of Final Map and Agreements.** After City Council approval, the Owner shall provide evidence of recordation to the Public Works Department.
 - 2. Approved Public Improvement Plans and Concurrent Issuance of Public Works Permit. Upon acceptance of the approved public improvement plans, a Public Works permit shall be issued concurrently with a Building permit.
- D. **Building Permit Plan Requirements**. The following requirements/notes shall be incorporated into the construction plans submitted to the Building and Safety Division for Building permits.
 - 1. **Design Review Requirements.** Plans shall show all design, landscape and tree protection elements, as approved by the Historic Landmarks Commission.
 - 2. Noise Mitigation Measures. A Noise Control Analysis for Granada Tower Refurbishment Project Residential Uses dated March 8, 2006 and an addendum letter addressing Roof Deck Mechanical Equipment Noise dated June 2, 2006 were prepared by Channel Island Acoustics for the subject project. The Noise Control Analysis and addendum letter preparer shall verify that all mitigation measures specified in the Analysis_that are required to reduce interior and exterior living area noise levels to acceptable levels as specified in the Noise Element Land Use Compatibility Guidelines have been incorporated into the construction plans to be submitted to the Building and Safety Division for Building Permits.
 - 3. **Utilities.** Provide individual water, electricity, and gas meters, and sewer lateral for each residential unit. Service lines for each unit shall be separate until a point five feet (5') outside the building.

- 4. **Water-Conserving Fixtures.** All plumbing fixtures shall be water-conserving devices in new construction, subject to the approval of the Water Resources Management Staff.
- 5. Conditions on Plans/Signatures. The final Staff Hearing Officer Resolution shall be provided on a full size drawing sheet as part of the drawing sets. Each condition shall have a sheet and/or note reference to verify condition compliance. If the condition relates to a document submittal, indicate the status of the submittal (e.g., Final Map submitted to Public Works Department for review). A statement shall also be placed on the above sheet as follows: The undersigned have read and understand the above conditions, and agree to abide by any and all conditions which is their usual and customary responsibility to perform, and which are within their authority to perform.

- E. **Construction Implementation Requirements.** All of these construction requirements shall be carried out in the field for the duration of the project construction.
 - 1. **Haul Routes.** The haul route(s) for all construction-related trucks, three tons or more, entering or exiting the site, shall be approved by the Public Works Director.
 - 2. **Construction Hours.** Construction (including preparation for construction work) is prohibited Monday through Friday before 7:00 a.m. and after 5:00 p.m., and all day on Saturdays, Sundays and holidays observed by the City of Santa Barbara, as shown below:

*When a holiday falls on a Saturday or Sunday, the preceding Friday or following Monday, respectively, shall be observed as a legal holiday.

When, based on required construction type or other appropriate reasons, it is necessary to do work outside the allowed construction hours, contractor shall contact the Chief of Building and Safety to request a waiver from the above construction hours, using the procedure outlined in Santa Barbara Municipal Code §9.16.015 Construction Work at Night. Contractor shall notify all residents within 300 feet of the parcel of intent to carry out night construction a minimum of 48 hours prior to said construction. Said notification shall include what the work includes, the reason for the work, the duration of the proposed work and a contact number.

- 3. **Construction Parking/Storage.** Construction parking and storage shall be provided as follows:
 - a. During construction, free parking spaces for construction workers and construction shall be provided on-site or off-site in a location subject to the approval of the Public Works Director.
 - b. Storage or staging of construction materials and equipment within the public right-of-way is prohibited.
- 4. **Gravel Pads.** Gravel pads shall be installed at all access points to the project site to prevent tracking of mud on to public roads.
- 5. **Street Sweeping.** The property frontage and adjacent property frontages, and parking and staging areas at the construction site shall be swept daily to decrease sediment transport to the public storm drain system and dust.
- 6. Construction Best Management Practices (BMPs). Construction activities shall address water quality through the use of BMPs, as approved by the Building and Safety Division.
- 7. Construction Contact Sign. Immediately after Building permit issuance, signage shall be posted at the points of entry to the site that list the contractor(s) name, contractor(s) telephone number, work hours, site rules, and construction-

related conditions, to assist Building Inspectors and Police Officers in the enforcement of the conditions of approval.

- 8. Construction Equipment Maintenance. All construction equipment, including trucks, shall be professionally maintained and fitted with standard manufacturers' muffler and silencing devices.
- 9. Unanticipated Archaeological Resources Contractor Notification. Prior to the start of any vegetation or paving removal, demolition, trenching or grading, contractors and construction personnel shall be alerted to the possibility of uncovering unanticipated subsurface archaeological features or artifacts associated with past human occupation of the parcel. If such archaeological resources are encountered or suspected, work shall be halted immediately, the City Environmental Analyst shall be notified and an archaeologist from the most current City Qualified Archaeologists List shall be retained by the applicant. The latter shall be employed to assess the nature, extent and significance of any discoveries and to develop appropriate management recommendations for archaeological resource treatment, which may include, but are not limited to, redirection of grading and/or excavation activities, consultation and/or monitoring with a Barbareño Chumash representative from the most current City qualified Barbareño Chumash Site Monitors List, etc.

If the discovery consists of possible human remains, the Santa Barbara County Coroner shall be contacted immediately. If the Coroner determines that the remains are Native American, the Coroner shall contact the California Native American Heritage Commission. A Barbareño Chumash representative from the most current City Qualified Barbareño Chumash Site Monitors List shall be retained to monitor all further subsurface disturbance in the area of the find. Work in the area may only proceed after the Environmental Analyst grants authorization.

If the discovery consists of possible prehistoric or Native American artifacts or materials, a Barbareño Chumash representative from the most current City Qualified Barbareño Chumash Site Monitors List shall be retained to monitor all further subsurface disturbance in the area of the find. Work in the area may only proceed after the Environmental Analyst grants authorization.

- F. **Prior to Certificate of Occupancy.** Prior to issuance of the Certificate of Occupancy, the Owner of the Real Property shall complete the following:
 - 1. Repair Damaged Public Improvements. Repair any damaged public improvements caused by construction (curbs, gutters, sidewalks, etc.) subject to the review and approval of the Public Works Department. Where tree roots are the cause of the damage, the roots shall be pruned under the direction of a qualified arborist.
 - 2. Complete Public Improvements. Public improvements, as shown in the building plans, including utility undergrounding and installation of street trees.

- 3. **Backflow Device.** Provide an approved backflow device placed on the property side of consumer's service pursuant to Santa Barbara Municipal Code Section 14.20.120.
- 4. **Noise Measurements.** Submit a final report from a licensed acoustical engineer, verifying that interior and exterior living area noise levels are within acceptable levels as specified in the Noise Element. In the event the noise is not mitigated to acceptable levels, additional mitigation measures shall be recommended by the noise specialist and implemented subject to the review and approval of the Building and Safety Division and the Historic Landmarks Commission (HLC).
- G. Litigation Indemnification Agreement. In the event the Staff Hearing Officer approval of the Project is appealed to the City Council, Applicant/Owner hereby agrees to defend the City, its officers, employees, agents, consultants and independent contractors ("City's Agents") from any third party legal challenge to the City Council's denial of the appeal and approval of the Project, including, but not limited to, challenges filed pursuant to the California Environmental Quality Act (collectively "Claims"). Applicant/Owner further agrees to indemnify and hold harmless the City and the City's Agents from any award of attorney fees or court costs made in connection with any Claim.

Applicant/Owner shall execute a written agreement, in a form approved by the City Attorney, evidencing the foregoing commitments of defense and indemnification within thirty (30) days of the City Council denial of the appeal and approval of the Project. These commitments of defense and indemnification are material conditions of the approval of the Project. If Applicant/Owner fails to execute the required defense and indemnification agreement within the time allotted, the Project approval shall become null and void absent subsequent acceptance of the agreement by the City, which acceptance shall be within the City's sole and absolute discretion. Nothing contained in this condition shall prevent the City or the City's Agents from independently defending any Claim. If the City or the City's Agents decide to independently defend a Claim, the City and the City's Agents shall bear their own attorney fees, expenses and costs of that independent defense.

- 3. PLEASE NOTE: A copy of this resolution shall be reproduced on the first sheet of the drawings submitted with the application for a building permit. The location, size and design of the construction proposed in the application for the building permit shall not deviate from the location, size and design of construction approved in this modification.
- 4. NOTICE OF TENTATIVE SUBDIVISION MAP (INCLUDING NEW CONDOMINIUMS AND CONDOMINIUM CONVERSIONS) TIME LIMITS:

The Staff Hearing Officer's action approving the Tentative Map shall expire two (2) years from the date of approval. The subdivider may request an extension of this time period in accordance with Santa Barbara Municipal Code §27.07.110 or the provisions of the California Subdivision Map Act..

We are hereby requesting a 3 year extension per City Code 27.07.110.B for the tentative map approved as SHO Resolution No. 043-06.

As you know the Granada Theater has been in the process of a major renovation. This renovation has resulted in a number of changes to both the utility service lines and the emergency egress of both the Granada Theater and the Granada Tower. These changes to both the utility systems and access will require numerous changes to the existing easements between the two properties. While we are proceeding forward and are working finalize the necessary revisions to the easements, to date we have not received the as-built utility locations from all of the various subcontractors involved in the theater renovation. This makes it impossible to complete the Final Map for the project in time.

We are requesting this extension to allow sufficient time for all of the utility relocations to be documented and for the necessary changes to easements to be accomplished. This extension will allow final map to correctly reflect the easement changes due the extensive remodeling of the theater.
