APPLICATION OF RODERICK BRITTON FOR THE BROUMAND FAMILY TRUST, 1268 BEL AIR DRIVE, APN 049-231-008, E-1 ONE-FAMILY RESIDENCE ZONE, GENERAL PLAN DESIGNATION: RESIDENTIAL, 3 UNITS PER ACRE (MST2008-00521)

The 11,404 square foot project site is currently developed with a single family residence with attached 2-car garage. The proposed project involves a remodel to the existing residence, which includes window changes to the west and south elevations and a 162 square-foot first floor addition to the residence. The discretionary application required for this project is a Modification to permit additions and alterations within the required ten-foot (10') interior setback (SBMC §28.15.060).

The Environmental Analyst has determined that the project is exempt from further environmental review pursuant to the California Environmental Quality Guidelines Section 15301.

If you, as an aggrieved party or applicant, disagree with the decision of the Staff Hearing Officer regarding the outcome of this application, you may appeal the decision to the Planning Commission. The appeal, accompanied by the appropriate filing fee per application, must be filed at the Planning & Zoning Counter within ten calendar days of the Staff Hearing Officer's decision.

If you challenge the permit approval or environmental document in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the Staff Hearing Officer at, or prior to the public hearing.
