12 UNITS PER ACRE (MST2008-00533)**

The 4,662 square foot project site is currently developed with a single-family residence and detached one-car garage. The proposed project involves demolition of the existing structures and the construction of a two-story single-family residence with detached two-car garage. The discretionary application required for this project is a Modification to permit the garage to be located within the required interior setback (SBMC §28.21.060).

The Environmental Analyst has determined that the project is exempt from further environmental review pursuant to the California Environmental Quality Guidelines Section 15303.

You are invited to attend this hearing and address your verbal comments to the Staff Hearing Officer. If you, as an aggrieved party or applicant, disagree with the decision of the Staff Hearing Officer regarding the outcome of this application, you may appeal the decision to the Planning Commission. The appeal, accompanied by the appropriate filing fee per application, must be filed at the Planning & Zoning Counter within ten calendar days of the Staff Hearing Officer's decision.

If you challenge the permit approval or environmental document in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the Staff Hearing Officer at, or prior to the public hearing.
