APPLICATION OF LISA PLOWMAN, AGENT FOR HABITAT FOR HUMANITY OF SOUTHERN SANTA BARBARA COUNTY, 618 SAN PASCUAL STREET, APN 037-102-023, R-3 ZONE, GENERAL PLAN DESIGNATION: RESIDENTIAL - 12 UNITS PER ACRE (MST2008-00059)

The proposed project involves construction of four new attached residential condominium units price restricted to low-income households, including two 981 square foot two-bedroom units, one 1,127 square foot two-bedroom unit, and one 789 square foot one-bedroom unit. Each unit includes one attached single-car garage between 212 and 242 square feet. The public alley on the 500 block of W. Ortega Street would provide automobile access to the site. Proposed grading totals 1,830 cubic yards, with 1,821 cubic yards of cut and 9 cubic yards of fill.

The discretionary applications required for this project are:

- 1. <u>Lot Area Modification</u> to allow two bonus density units (SBMC §28.92.110);
- 2. <u>Parking Modification</u> to allow one covered space for each unit instead of the required one covered and one uncovered space for each unit (SBMC §28.92.110);
- 3. <u>Fence/Wall Height Modification</u> for fences and walls to exceed eight feet in height within the interior setback (SBMC §28.92.110);
- 4. <u>Wall Height Modification</u> for walls within ten feet of the front line to exceed 3½ feet in height (SBMC §28.92.110);
- 5. <u>Front Setback Modification</u> to allow a patio overhang to encroach 3½ feet into the ten foot front setback (SBMC §28.92.110);
- 6. <u>Interior Setback Modification</u> for the building to encroach one foot into the six foot interior setback (SBMC §28.92.110);
- 7. Rear Setback Modification for the building's second story to encroach 1¼ feet into the ten foot rear setback (SBMC §28.92.110); and
- 8. <u>Tentative Subdivision Map</u> for a one-lot subdivision to create four residential condominium units (SBMC Chapters 27.07 and 27.13).

The Environmental Analyst has determined that the project is exempt from further environmental review pursuant to the California Environmental Quality Guidelines Section 15332 (Infill Development Projects).

You are invited to attend this hearing and address your verbal comments to the Staff Hearing Officer. Written comments are also welcome up to the time of the hearing, and should be addressed to the Staff Hearing Officer Secretary, P.O. Box 1990, Santa Barbara, CA 93102-1990. This is the only notification you will receive for this development application. The scope of this project may be modified under further review. If you challenge the permit approval or environmental document in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the Staff Hearing Officer at, or prior to the public hearing.
