**APPLICATION OF ERIC SWENUMSON FOR GREGORY & WENDI CHITTICK, 324 E. CALLE LAURELES, APN 053-084-015, E-3 ONE-FAMILY RESIDENCE/SD-2 SPECIAL DISTRICT OVERLAY ZONES, GENERAL PLAN DESIGNATION: 5 UNITS PER ACRE (MST2009-00084)**

The 6,500 square foot project site is currently developed with a single-family residence and attached one-car garage. The proposed project involves a remodel of the existing residence, an 89 square foot first-floor expansion, a 291 square foot second story addition, and demolition and replacement of a 289 square foot one-car garage with 39 square feet of storage space. As a part of the remodel the roof will be increased from a 3/12 to a 5/12 pitch. The discretionary application required for this project is a Modification to permit the increase in roof pitch within the required six-foot interior setback (SBMC §28.15.060).

The Environmental Analyst has determined that the project is exempt from further environmental review pursuant to the California Environmental Quality Guidelines Section 15305.

You are invited to attend this hearing and address your verbal comments to the Staff Hearing Officer. Written comments are also welcome up to the time of the hearing, and should be addressed to the Staff Hearing Officer Secretary, P.O. Box 1990, Santa Barbara, CA 93102-1990. If you, as an aggrieved party or applicant, disagree with the decision of the Staff Hearing Officer regarding the outcome of this application, you may appeal the decision to the Planning Commission. The appeal, accompanied by the appropriate filing fee per application, must be filed at the Planning & Zoning Counter within ten calendar days of the Staff Hearing Officer's decision.

If you challenge the permit approval or environmental document in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the Staff Hearing Officer at, or prior to the public hearing.
