APPLICATION OF MAURY TREMAN, AGENT FOR TERRACE VISTA VILLAS HOMEOWNERS ASSOCIATION, 30 SANTA YNEZ STREET, APN 015-330-001, E-1 ONE-FAMILY RESIDENCE/PUD PLANNED UNIT DEVELOPMENT ZONES, GENERAL PLAN DESIGNATION: 12 UNITS PER ACRE (MST2009-00230)

The 1.52 acre site is currently developed with four condominium units. The proposed project involves the installation of a vehicular entry gate for the property. The discretionary application required for this project is a Modification to permit the gate to exceed the maximum allowable height of 3½' within the first 20' from the front lot line, when located within 10' of the driveway (SBMC §28.87.170).

The Environmental Analyst has determined that the project is exempt from further environmental review pursuant to the California Environmental Quality Guidelines Section 15303 & 15305.

You are invited to attend this hearing and address your verbal comments to the Staff Hearing Officer. If you, as an aggrieved party or applicant, disagree with the decision of the Staff Hearing Officer regarding the outcome of this application, you may appeal the decision to the Planning Commission. The appeal, accompanied by the appropriate filing fee per application, must be filed at the Planning & Zoning Counter within ten calendar days of the Staff Hearing Officer's decision.

If you challenge the permit approval or environmental document in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the Staff Hearing Officer at, or prior to the public hearing.
