The 2,102 square foot project site is currently developed with a single family residence. The proposed project involves a request to legalize "as-built" construction. The discretionary applications required for this project are Modifications to allow the "as-built" 68 square-foot bedroom addition, a laundry cabinet, and water heater enclosure to be located within the interior setback and open yard areas and parking within the front and interior setbacks (SBMC§28.18.060 & 28.90.001.I).

The Environmental Analyst has determined that the project is exempt from further environmental review pursuant to the California Environmental Quality Guidelines Section 15301 & 15305.

You are invited to attend this hearing and address your verbal comments to the Staff Hearing Officer. The appeal, accompanied by the appropriate filing fee per application, must be filed at the Planning & Zoning Counter within ten calendar days of the Staff Hearing Officer's decision.

If you challenge the permit approval or environmental document in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the Staff Hearing Officer at, or prior to the public hearing.
